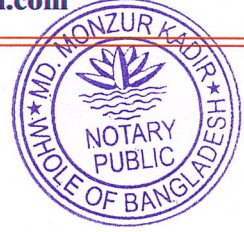

The accused's learned counsel, Faujdar [Fou:] Ka, submitted a petition under Section 265(H) of the Code of Criminal Procedure. He submitted in this regard that this case was filed unnecessarily for political reasons during the time of the then fascist government. He further submitted that the then IGP Shahidul Haque mentioned in his written book that the then head of government told him that the incident under Section 32 could have been avoided. It is noteworthy that this very IGP Shahidul Haque, after the change of government, is currently facing trial for crimes against humanity and is in jail. Considering all these matters, there remains deep doubt about the authenticity of this case. After the filing of this case in 2017, the charge was framed on 13/01/2021. During this long period, the testimony of only one witness has been recorded.

Reviewing the statement given by the plaintiff, it is observed that the sole victim died in a suicide bomb attack. The plaintiff filed the case upon the direction of DC Maruf. Furthermore, reviewing the documents, it is seen that all the accused were activists opposing the previous fascist government. In the political culture of Bangladesh, it is observed that the ruling authorities often obstruct programs organized by opposition groups and attempt to maintain power through the filing of cases. In the present case, this court firmly believes that a similar situation has occurred.

The learned P.P. for the State did not raise any strong objection during the hearing.

In view of the statement of the accused and the overall consideration, the application for acquittal of the accused under Section 265 (H) of the Code of Criminal Procedure is granted and the accused Tajrim Khanam Shuvo, Nab Muslim Abdullah, Nazmul Hasan Mamun, Abdullah Aichan Kabiraj, Md. Kamrul Islam Shakil, Akram Hossain Khan Niloy, Tarek Mohammad Adnan, **TANVIR YASIN KARIM**, Sadia Hosna Lucky, Abul Kashem Fakir,

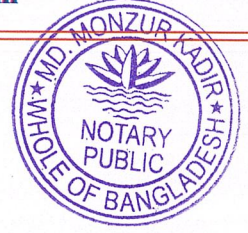
